PROVISIONS ON THE FORMAT OF THE COMMISSION STIPULATION

1. Provisions of the format of the Commission Stipulation herein constitute a reference in preparing a Stipulation of Behavior Change.
2. The preparation of the Commission Stipulation by the Commission Panel shall be assisted by a Clerk.
3. The format of the Commission Stipulation as intended herein shall contain general matters that need to be indicated and the form of the Commission Stipulation.
4. The difference of the content of the Commission Stipulation signed by the Commission Panel and the Clerk from the format as indicated herein shall not immediately cause the said Commission Stipulation to be formally defective.
5. The composition of the Commission Stipulation shall consist of the following:
  - a. The Head Part
    - 1) The Commission Stipulation shall use heading papers with the Logo of Eagle on the upper part;
    - 2) The inscription "STIPULATION" shall entirely be written in uppercases and shall be written symmetrically below the letter head;
    - 3) The case number shall be written symmetrically below the inscription "STIPULATION".
  - b. The Opening Part shall contain an opening narration and the identity of the Reported Party or Reported Parties;
  - c. Regarding the Alleged Violation
    - 1) The inscriptions "REGARDING THE ALLEGED VIOLATION" shall be entirely written in uppercases without spaces between the letters and shall be written symmetrically;
    - 2) Each content/elucidation regarding the alleged violation shall be provided with a serial number.
  - d. Regarding the Behavior Change Integrity Pact
    - 1) The inscriptions "REGARDING THE BEHAVIOR CHANGE INTEGRITY PACT" shall entirely be written in uppercases without spaces between the letters and shall be written symmetrically;
    - 2) Each content/elucidation regarding the Behavior Change Integrity Pact shall be provided with a serial number.

- e. Regarding the Report on the Oversight of Behavior Change shall contain the result of the oversight of the implementation of the Behavior Change Integrity Pact as prepared by the Examination Investigators.
- f. The content of the Commission Stipulation shall consist of:
  - 1) The Dictum started with the inscription "STIPULATE" shall be entirely written in uppercases and shall be placed symmetrically;
  - 2) Each order of the Commission Stipulation shall be provided with a serial number using Arabic numerals.
- g. The Closing Part shall consist of:
  - 1) the day and date of the making of the Commission Stipulation;
  - 2) the day and date of the reading out of the Commission Stipulation;
  - 3) the names of the Chairman and members of the Commission Panel and the clerk;
  - 4) the signatures of the Commission Panel and the Clerk as well as affixed with the stamp of the Commission.
- 6. The numbering of the Commission Stipulation shall follow the procedures as provided for in Regulation of the KPPU regarding Official Manuscript Management.
- 7. The format of the Commission Stipulation shall be as intended in the following example:
